- 1.) I agree to pay \$60.00 Processing Fee (non-refundable) prior to moving in. I agree to pay rent of \$90.00 per week to be paid on Friday.
- 2.) I agree to secure and maintain employment during my stay at the Wenholz House.
- 3.) I agree to maintain my personal hygiene, which includes showering, shaving, and doing laundry.
- 4.) I agree to keep my bed made and my personal area clean, and perform all clean up chores assigned to me.
- 5.) I agree that I will not engage in any physically aggressive behavior towards anyone during my stay.
- 6.) I will not verbally threaten anyone.
- 7.) I agree to submit to a Blood Alcohol Testing and/or Urinalysis at the discretion of Directors. I agree that a positive result from tests will result in immediate dismissal from the Wenholz House. I further agree that possession of alcohol in any form, or possession of any mind altering substance will result in immediate dismissal from Wenholz House.
- 8.) NO FACIAL JEWELRY ALLOWED ON THE PROPERTY!
- 9.) NO REFUNDS FOR ADVANCED RENT!!
- 10.) Wenholz House is not responsible for property left behind. You have 48 hours to pick up property.
- 11.) I agree to sign in and out anytime I leave facility. I agree to follow curfew and lights out policy  
Curfew Sunday-Thursday is 10:30pm, and 1am Friday and Saturday. Lights out is one hour after curfew.
